This STALLION BREEDING CONTRACT for the breeding season of 2008 is made and entered into on this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_ is by and between JC Painted Acres, hereinafter designated Breeder and \_\_\_\_\_, hereinafter designated Mare Owner. Mare owner agrees to breed the mare Reg. No. \_\_\_\_\_ to the stallion JC POCO SHABACH, Reg. No. 740,870 for the fee of **\$400.00 plus \$50.00 booking fee** for a live color foal, subject to the following conditions.

1. Breeder agrees to provide suitable facilities for the care and feed of the mare and/or foal while in their custody. Mare Owner agrees to pay for care and feed at the rate of **\$7.00** per day for wet mares and **\$5.00** per day for dry mares.
2. Mares must be halter broke. ANY and ALL shoes must be removed for the safety of the Stallion.
3. The mare shall be in a healthy and sound breeding condition, free from infections, contagious or transmissible diseases. Photocopy of registration papers (both sides), plus a immunization record must accompany mare.
4. Contract contains a "Live Color Foal Guarantee". A live foal is described as a newborn foal which stands and nurses without assistance. If foal is born dead, return privileges for the 2009 season only if Breeder is notified within 7 days and receives a veterinarian's statement confirming death. Being pronounced "safe in foal" the mare should miscarry, abort or prove barren after leaving the Breeder's premises. Mare Owner has the privilege to return for breeding during the current breeding season FEBRUARY-1 through JULY-1. Or the following year.
5. Color foal Guarantee will be honored only if APHA / PtHA registry rejects full or minimal white registry. Mare owner must have a written statement from said registries and a DNA test must be given to the foal at the cost of the mare owner to prove JC POCO SHABACH is in fact the sire and no other stallion came in contact with mare.
6. A "Breeder's Certificate" will be issued for the foal, conceived by this mating, when the stallion fee and all other expenses have been paid in full; when the mare has produced a live foal by this mating & when a photo of the resulting offspring is sent to JC Painted Acres.
7. Both parties agree that JC Painted Acres are not liable for death, sickness and/or accident including consequential damages caused to the mare and/or foal unless caused by willful negligence of the Breeder; and the Mare owner is not liable for the death, sickness and/or accident including consequential damages caused to the stallion.
8. It is further agreed that should the stallion die, be sold by the owner, or become unfit for service prior to settling the mare, that \$ 400 of the breeding fee will be

refunded, if it has been paid in full, thereby canceling this entire contract; or, if mare dies or becomes unfit to breed before being pronounced in foal, the Breeder may substitute another mare according to paragraphs 3 & 4 as a replacement.

9. This contract is entered into the State of IN and will be interpreted and enforced under the laws of that state.
